

# Installation Instructions Cable Bikini

### Vehicle Application

• Jeep Wrangler JK (4 Door) Fits 56823,54723,55011 Door Surrounds 2010-current OEM Softtop Part Number: 52594





This product requires 2010-Current OEM or Bestop Door Surrounds.

### Installation Tips

Before you begin installing this assembly, read all instructions thoroughly.

### For a smooth fit:

For ease in installation, the product should be installed at temperatures above 72° F. Below this temperature, the fabric may contract an inch or more, making it difficult to fit to the vehicle. It is normal for fabric to contract and wrinkle when stored in the shipping carton. Within a few days after the installation, the fabric will relax and the wrinkles will disappear.

WARNING This product is designed primarily to enhance the appearance of the vehicle and to shield the occupants from ordinary weather conditions. Do not rely in any way on the components of this product to contain occupants within the vehicle, or to protect against injury or death in the event of an accident. This product will not protect the occupants from falling objects. Never operate the vehicle in excess of manufacturer's specifications.

### WEAR SEAT BELTS AT ALL TIMES

Read and follow, precisely, all installation instructions provided when installing product. Failure to do so may result in a poor fit and could place occupants of the vehicle in a potentially dangerous situation.





### Hard Top Installation

# **Install Spring Tension Straps**

Place a Spring Tension Strap and then a Rear Tension Strap on an M6 x 20mm Bolt and use a T-30 Torx wrench to install the bolt in the top hole in the sport bar behind the seat belt on each side of the Spring Tension Strap and Rear Tension Strap

#### 2 **Install Center J-Hook Straps**

Thread the end of one of the J-Hook Straps through one of the buckles on the center flap inside the Bikini. Repeat with the other J-Hook Strap.



### Secure Header to Windshield

Center the Bikini on the vehicle. Place the tabs on the Header Knob Bases above the footman loops in the windshield frame. Place a Header Knob Plate under a footman loop. Install a Header Knob through the plate and footman loop and thread it into the Header Knob Base. Repeat this with both Header Knob Bases.

# **4** Drape Cable Bikini over Vehicle

Drape the Cable Bikini over the vehicle. Make sure that the Bikini cable lies inside the channel on the door surround.

# **4** Drape Cable Bikini over Vehicle

Drape the Cable Bikini over the vehicle. Make sure that the Bikini cable lies along the outside of the channel on the door surround.





# **5** Install Spring Buckle Straps

Locate the spring pocket on each side of the Cable Bikini. Install a Spring Buckle Strap on the each spring.



# 6 Secure Rear Buckle Straps

Locate the Rear Tension Strap on the sport bar installed in Step 1. Thread the end of the strap through the buckle. Leave loose. Repeat on both sides of the vehicle.



### **7** Secure Side Buckle Straps

Locate the Spring Tension Strap on the sport bar. Make sure the pocket is outside the door surround. Thread the end of the strap through the buckle on the Spring Buckle Strap and pull tight. Repeat on both sides of the vehicle.

### **Care and Maintenance of your Bestop Product**

Water: Seeping through at the seams may be stopped by applying 3-M Scotchgard<sup>®</sup> on the inside of the seams. Rips in the fabric may be repaired with Bondex<sup>®</sup> iron on patches. Iron the patches to the Inside of the top, carefully following the Bondex<sup>®</sup> instructions.
